Answer: No. Cash outflows will continue to be reduced. Drilling is completed as the Company's focus has become the Scoping Study for Hualilan Gold Project and an updated MRE at the El Guayabo Gold Copper Project. Drilling costs we \$2.1M during the quarter. Additionally, the estimated quarters of funding available calculation does not include item 2.5, which has a positive impact on cashflow of almost \$1.5M and will continue to have a positive impact in coming quarters. The Company has initiated a cost reduction program across its operations, including corporate.
