RE: NOTICE UNDER SECTION 708A

The Board of Challenger Exploration Limited (the Company) issued 11,666,667 ordinary shares for deferred consideration for the Hualilan Gold Project, as per shareholder approval dated 29 April 2019 and 375,000 ordinary shares in lieu of cash consideration for salaries as announced on 8 April 2020 without disclosure to investors under Part 6D.2, in reliance on Section 708A(5) of the Corporations Act.
